Closure of Coast Guard in Ucluelet

Dear Mayor Irving and Council:

On behalf of the Ucluelet and Area Childcare Society, I would like to draw your attention to the need to formalize the ongoing agreement between the UACCS and the District of Ucluelet for the occupancy of the daycare space at the Ucluelet Community Centre.

Prior to the building of the daycare, society directors worked with district staff to draft a memorandum of understanding. This document was meant to outline each group's expectations and commitments. Unfortunately, the document was not completed before the space was built.

Following our occupancy of the daycare, Abby Fortune presented us with a standard lease. The UACCS did not feel that this agreement acknowledged our financial contribution to the building. We asked that the lease be revised.

We are grateful for the tenancy arrangement that council has granted the society. None the less we would like to see our financial contribution to the building acknowledged in the lease. The society partnered with the District of Ucluelet in applying for the Town's for Tomorrow grant which was successful in the amount of \$390,000. The UACCS was asked to contribute an additional \$110,000 towards the building of the daycare. The DOU holds a separate grant of \$50,000 towards furnishings for UACCS and it is our understanding that this has been applied to the \$110,000 leaving \$60,000 owed by the society to the district.

Our board met with Abby and Derek Drake on December 17, 2012 and discussed this situation at length. At that time, Abby assured us we would receive a draft lease in January. We have followed up repeatedly, but have not received the lease. On February 18 we were told that the lease was on the CFO's desk but we have still not received it. As we have told Abby, this is our main priority and we would like to see the arrangements finalized before April 15 when our new manager begins.

The UACCS asks that council direct staff to work with us to draft a lease that acknowledges each of our contributions and ongoing responsibilities at which time we will happily arrange the outstanding payment.

Re: Derelict and abandoned vessels

As Chair of the Islands Trust Council, I'm writing to you in response to the recently released Transport Canada report on the study of the extent of abandoned and derelict vessels in Canada.

The Islands Trust has been concerned with derelict and abandoned vessels for decades and has been asking since 2010 for the Province of British Columbia and the federal government to develop a coordinated approach to the timely removal of all types of derelict and abandoned vessels, barges and docks. Although we're grateful for the leadership shown by Transport Canada staff in some specific derelict vessel removals last year, no permanent solutions have been adopted. Federal and provincial departments continue to say jurisdiction for the issue is unclear, as was evidenced in recent media coverage on derelict vessels in Howe Sound.

Derelict and abandoned vessels, barges and docks pose environmental contamination and safety risks. They also create visual pollution in our communities that negatively impacts tourism and commercial activities. As confirmed in the recently released report, the age of vessels in Canadian waters is increasing and so the incidence of abandoned and derelict vessels is expected to increase and become unmanageable.

We appreciate that Transport Canada undertook the study and released the report. However, we are concerned the report significantly underestimates the number of derelict and abandoned vessels in BC. The report cites only 42 derelict and abandoned vessels on the whole BC coast, but that can't be right, given the 60 problem vessels our staff reported to your survey after a very brief poll in just the Islands Trust Area. Also, given the ten-month wait for the report, we had hoped it would contain more substantive analysis of the root causes of the problem, possible preventative measures, and existing barriers to action.

We are pleased Transport Canada and other federal departments are forming an inter-jurisdictional working group with interested provincial agencies. There is already an inter-jurisdictional working group for the BC coast (although it has been dormant while waiting for this federal inventory); we've been grateful for the participation of Transport Canada staff.

We support the goals of the new working group as outlined in the recommendations section of the report and suggest that the working group start by undertaking more rigorous data collection and detailed mapping. We also encourage you to include local government representatives on the working group, and ask that you consider inviting Islands Trust staff to participate.

We look forward to the working group concluding its work expeditiously, in consideration of previous delays in addressing this issue. The number of abandoned vessels in the Islands Trust Area overdue for removal is increasing every month. Given the need for immediate action, we request that Transport Canada provide interim funding for vessel removals while awaiting the advice of the working group.

We look forward to your response to this letter and to increased attention from Transport Canada to this important issue.

Recommendation:

1. THAT Council consider approval of the following recommendation:

A Development Permit be issued on the above referenced property subject to the conditions outlined below and within the body of this report.

- a) Full compliance with the current B.C. Building Code and all other relevant requirements through the submission of a complete Building Permit application.
- b) Adherence to the submitted Development Permit drawings and documentation including conditions and commitments outlined herein and noted in the following report.
- c) The issuance of a variance to the front yard setback from the CS-2 front yard setback requirement of 4.5m from Peninsula Road frontage to a setback of 1.0m.

Purpose:

To consider the issuance of a Development Permit and Variance to allow a metal and glass awning over the patio of Unit 7, 1620 Peninsula Road all in accordance with the Development Permit Guidelines for Development Permit Area No. 7 (Peninsula Road) under the Official Community Plan (OCP).

Background:

Planning Staff are in receipt of an application for a Development Permit at the above referenced address. The property falls within the area described in the OCP as Peninsula Road – Development Permit Area 7. The category under the Local Government Act in which this Development Permit Area was established relates to Form and Character.

The Development Permit Guidelines, adopted under the Official Community Plan, underscore the need to address the architectural and urban design of proposals which

serves to benefit both residents and visitors alike. The mixture of retail, service commercial and tourist commercial uses adjacent to the Village Square requires that particular attention be paid to architectural design and uses as they relate to the mix of pedestrian/vehicular uses in a town centre. Landscaping and use of outdoor space should encourage the revitalization of the neighborhood.

Development Permit Application:

The subject site is located on the south side of Peninsula Road (<u>attachment 1</u>) and is Zoned CS-2 – Service Commercial. It contains a one storey concrete block commercial strip with individual retail units facing east onto a parking lot.

The existing commercial strip 'mall' is built in a fashion which is indicative of the late 1960's celebration of the automobile. Its large paved parking lot is flanked by one storey box like structures which flank either side. Minimalist architecture prevailed in the late 60's, the result of which was that often little façade treatment or material relief would be presented at a pedestrian level or to the street. In the case of the subject site, it meant a blank concrete wall facing Peninsula Road and any façade treatment at all was applied to the unit frontages interior to the site. The intent was to encourage pedestrian movement within the site itself and to leave the streets for vehicles. These are no longer the principles on which town centres are planned and pedestrian movement and participation from a street level is encouraged.

The applicant is proposing to add a metal and glass awning (<u>attachment 2</u>) over their existing patio area of Unit 7, known as Roman's Restaurant. The proposed awning does not increase the patio area and thus does not increase any parking requirement beyond that which would have been required for existing space.

The applicant is proposing to add a metal and glass awning (attachment 3) over the existing patio located to the southeast of the restaurant frontage. The awning will be painted black and the glass will be tinted in 600mm wide sheets. It will be attached to the existing roof overhang and the outer support posts will land on the existing concrete and stone patio wall while the interior post will land on a footing cut into the patio slab. The awning structure, its bases and its lateral load will be engineered. Through discussions with Planning Staff the proponent will add a rough cut 2x8 cedar fascia with natural finish to align the awnings materials more to the direction of the Development Permit Guidelines.

Part of the proposed awning will be located within the 4.5m setback required for properties in the CS-2 zone fronting off of Peninsula Road. The resulting encroachment will require a development variance. Considering the existing building and patio are within the front setback at 1.0m off the front property line it would be consistent and encouraged to allow for a variance for the awning.


Summary:


The Development Permit Guidelines encourages pedestrian connectivity and outdoor patios are a permeable layer between pedestrian traffic to indoor space creating a more vibrant pedestrian experience. A well done awning can extend that experience in our exciting weather changes. The awning materials fit within the Development Permit Guidelines form and character requirements. It would be encouraged that the proponent continues to upgrade the building aesthetics, with a consistent approach to the recent work done to an adjacent unit, the Barkley Café.






