Dear Mayor & Council, and Regional Directors,

Thanksgiving seems appropriate to again invite support for sustainable development and our proposed December 11th' Proclamation, 'A Day For Our Common Future'.

Just two months away, December 11th is the day the United Nations formally received the first global sustainable development report from the World Commission on Environment and Development in 1987. And this year December 11th is also the last day of the UN Paris Conference, which many governments and nations are marking as a turning point in global efforts to address climate change.

In 2014 the Province of British Columbia and 15 BC cities signed our Proclamation, which translates to support from governments representing approximately 4,658,000 BC residents, 13% of Canada's population. With this in mind we are reaching out across BC and Canada this year, to similarly invite expressions of support and community initiatives for sustainable development.

Considering the UN's Global Sustainable Development Report just released, and Pope Francis' call for governments to implement carbon reduction measures, we believe that local and senior governments here in Canada could set an example this year. Declaring December 11th 'A Day For Our Common Future', the last day of the COP 21 Paris Conference on Climate Change, helps deliver a message of hope and sustainability to the world.

We would then ask that you consider this opportunity to bridge economic and environmental considerations - and declare, proclaim, observe or simply announce December 11th 2015, 'A Day for Our Common Future'.

Whatever your decision may be ...please also let us wish you the very best as you address economic and environmental matters at this important time. If we can in turn be of service please do not hesitate to be in touch.



Reduced speed zone and new crosswalk lines at the Rainforest Trail on Highway 4 in Pacific Rim National Park Reserve

Pacific Rim National Park Reserve, BC, October 13, 2015

- Drivers should be aware of the new 60 km/hr speed zone at the Rainforest Trail pedestrian crosswalk on Highway 4, the Pacific Rim Highway.
- Pedestrian crosswalk signs, road markings, and advance-warning strips have been added to the highway. Drivers are reminded that, under BC traffic laws, they must yield to pedestrians in a marked crosswalk.
- Pedestrians should continue to exercise care and attention when crossing the highway and ensure drivers are stopped or stopping before stepping into the crosswalk.
- Visitors of all ages and abilities cross the highway to experience the Rainforest Trail. The new reduced speed zone and marked crosswalk will help alert drivers and reduce the risk of incidents.

RECOMMENDATION(S)

1. That the report regarding District of ##### ICBL Bylaw No. ###, 2015 be received.

2. That District of ##### ICBL Bylaw No. ###, 2015 be given first, second and third readings.

PURPOSE

To support small businesses, red-tape reduction and more open for business communities through the establishment of an ICBL.

OPTIONS/ALTERNATIVES

- 1. Council could accept District of ##### ICBL Bylaw No. ###, 2015.
- 2. Council could deny District of ##### Inter-Community Business Licence Bylaw No. ###, 2015.
- 3. Council could allow a two-year trial period for a district of Tofino and Ucluelet specific ICBL agreement.

DISCUSSION

Created in partnership with local governments, the Union of British Columbia Municipalities and the Province of British Columbia (Province), the ICBL streamlines and simplifies the licensing process, making it easier to do business in British Columbian communities. Since this is a regulation bylaw, municipalities do not require any permission from the Province.

The Province is committed to working with local governments and First Nations to expand existing and introduce new mobile business licence agreements in British Columbia. This is part of an effort to promote the success of the small business sector and to reduce barriers to doing business in the Province. The Province has stated that

businesses, residents and communities benefit from ICBLs. The Province believes simplifying the licencing process increases compliance. Only one participating municipality will complete the application process and approve the business licence for all participating municipalities. A small reduction in administrative burden and cost is expected for each municipality. A simplified process will likely improve the sharing and flow of information between local governments and increase the ability to monitor compliance. Increased compliance and reduced administration cost contribute to relative revenue neutrality overall between pre and post implementation of an ICBL agreement.

The Province carried out analysis to get a sense of the potential impact of an ICBL program to revenues. Analysis suggests both the districts of Tofino and Ucluelet will experience a small increase in revenues with the implementation of an ICBL at the \$150 fee level whether compliance is factored in or not (see tables below). The Central Island ICBL Group will also experience an overall revenue gain. Any gain or loss in revenue for Participating Municipalities due to the ICBL will be minor, particularly when compared with the base business licence revenues.

Presently British Columbia boasts 10 existing mobile business licence agreements with 69 different participating communities. Municipalities are reporting increased licensing compliance, reduced administrative burden, reduced business licence application processing, improved information flow between local governments and increased ability to monitor compliance due to the agreements. Residents benefit from increased choice and consumer confidence in service providers. Businesses save time and money by purchasing one mobile business licence instead of multiple non-resident permits, reduce administrative burden, and ICBLs allow businesses to operate where their services are needed. The issuance of ICBLs will enhance staff efficiency, expand the job market and help develop local prosperity.

The districts of Tofino and Ucluelet currently operate as two separate local government entities and issue business licences within their own jurisdiction. The Alberni Clayoquot Regional District does not require business licensing within their jurisdiction. With the exception of the Central Okanagan Regional District, regional districts are not empowered by legislation to regulate business. If the districts of Tofino and Ucluelet wished to partner with the Alberni Clayoquot Regional District, they could explore the Central Okanagan Regional District's participation in the Okanagan Similkameen ICBL model. The partnership could create a revenue generation opportunity for the Alberni Clayoquot Regional District and more even regulation of businesses within the region.

The central Vancouver Island communities implemented an ICBL in 2014 that includes the City of Campbell River, Town of Comox, City of Courtenay, Village of Cumberland, City of Duncan, Town of Lake Cowichan, Town of Ladysmith, City of Nanaimo, Municipality of North Cowichan, City of Parksville, City of Port Alberni and Town of Qualicum Beach. In late August 2015 the Province hosted a meeting in Nanaimo bringing together the districts of Tofino and Ucluelet as well as the Central Island ICBL group to discuss the partnership opportunity. The Central Vancouver Island ICBL group welcomed the districts of Tofino and Ucluelet to join their agreement.

An ICBL will simplify the business licencing process and the associated supplementary procedures. It will allow mobile businesses (e.g. contractors, caterers, and other service providers) to operate across the participating local governments, without having to apply for multiple businesses licences. Businesses eligible for an ICBL could be defined as a business that performs service or activity within more than one jurisdiction by visiting clients to provide a service rather than having clients visit them for a service. Implementing a straightforward ICBL eligibility definition will simplify administration and enforcing compliance. A broad definition will ensure all mobile business can benefit from the program and some do not feel excluded from the opportunity.

An ICBL Bylaw will be time and cost effective for all parties involved and will ultimately simplify the entire process. Mobile businesses will no longer need to separately receive licencing from the districts of Tofino and Ucluelet. Instead, one business licence will be valid for multiple jurisdictions throughout the entire central Vancouver Island region. In 2014, some 194 mobile businesses purchased licences from the districts of Tofino and Ucluelet, 30 of which were businesses within the central Vancouver Island ICBL municipalities.

Strategic Plan

The districts of Tofino and Ucluelet will be required to adopt the ICBL Bylaw. The central Vancouver Island communities would only need to amend their existing bylaws to include the districts of Tofino and Ucluelet. After adoption, any municipalities who wished to opt-out of the agreement can do so by following the procedure outlined in the bylaw itself. It is worth noting that the process for dropping out of an ICBL agreement is not difficult and, out of the 10 existing ICBL agreements in British Columbia, none of the 69 communities have done so. Clearly, participating communities are seeing the value of the ICBL programs.

A business will apply for an ICBL from the Participating Municipality in which it has a fixed location.

Partnering with the central Vancouver Island group will be easier than developing a common set of standards and fees to form a district of Tofino ad Ucluelet ICBL specific Bylaw. The broader partnership throughout central Vancouver Island also expands the benefits of the ICBL program throughout a broader region.

Any mobile business licence holder will be made aware that they must meet the business licencing requirements of the participating municipalities in which it is working. Any business found to be operating without a valid non-resident business licence could be subject to bylaw violation notices and any corresponding fines.

Under the ICBL agreement, the participating local governments have agreed to allow non-resident businesses from within all of the participating local governments to operate in their individual local government on the basis of one ICBL purchased from their home municipality. Businesses outside the boundaries of these participating local governments will not be eligible for ICBLs and must purchase business licences from each or any of the local governments in which they wish to operate.

The Province maintains a central database of ICBL program information (www.mobilebusinessregistry.ca). This shared database allows municipal staff to carry out licence compliance checks. The Province provides this service without cost to the participating local governments.

Sustainability Guiding Principles

The ICBL bylaw will help contribute towards a more open for business community, support small businesses and reduce red tape, enabling a more robust and prosperous community.

Policy Implications

Council may, pursuant to Section 8(6) of the Community Charter regulate in relation to business.

Section 14 of the *Community Charter* states that two or more municipalities may, by bylaw adopt by the Council of each participating municipality, establish an Inter-Community scheme in relation to one or more matters.

Section 15 (1) states that Council may provide terms and conditions that may be imposed for obtaining, continuing to hold or renewing a licence, permit or approval and specify the nature of the terms and condition and who may impose them.

Once Council has given notice of its intention to adopt the ICBL Bylaw by publishing notice in two consecutive issues of a newspaper, the last publication appearing not less than three (3) and not more than ten (10) days before the hearing and has provided an opportunity for persons who consider they are affected by the bylaw to make representations to Council at a hearing pursuant to Section 59 of the *Community Charter*.

Every ICBL will be issued on a standard form and will include the nature of the business, mailing address, contact information, number of persons engaged or occupied in the business, number of goods sold or offered for sale, and other information regarding the business that may be needed. Each Participating Municipality will provide standardized information to all Participating Municipalities regarding the ICBLs they have issued through the Mobile Business Registry hosted by the Province.

Financial Implications

The Central Island ICBL cost is \$150.00. The ICBL cost is separate and additional to the Business Licence cost. Each business owner has the option to purchase the additional ICBL if they will be performing their services across multiple jurisdictions. The fee will be retained by the Participating Municipality that issues the licence as they perform the administrative tasks associated to obtain the ICBL. An ICBL can only be purchased from the community in which the mobile business has a storefront or business mailing address to ensure businesses are not strategically purchasing licences from communities with lower base business licence fees.

Communication Strategy

The ICBL bylaw will be communicated to staff and business owners. Notice will be advertised in the local newspaper and the bylaw will be added to the municipal website. It will also be advertised during business licence renewal time. A survey could be sent to business owners to gain their buy-in and better predict the effectiveness of the ICBL

bylaw. The Province will develop a news release in partnership with the municipality and perhaps support an event to help raise awareness and celebrate the launch of the new ICBL partnership.

Analysis/Application of Recommended Course of Action

- 1. The District of #### will create an ICBL bylaw based on the Central Island ICBL bylaw.
- 2. The districts of Tofino and Ucluelet will have a meeting with representatives from the Central Island ICBL group to confirm buy-in for the ICBL bylaw and the partnership.
- 3. Councils will give notice of its intention to adopt the bylaw by publishing notice in the newspaper and will provide an opportunity for people to make representation to Council at a hearing.
- 4. The districts of Tofino, Ucluelet and Central Vancouver Island group will amend and adopt the ICBL bylaw.
- 5. The Participating Municipalities will offer an ICBL to all business owners starting January 1, 2016.
- 6. Municipalities that do not wish to participate in the ICBL bylaw after adoption can contract out by following the withdrawal process that is described in the bylaw

A BYLAW TO ESTABLISH A SCHEME FOR INTER-COMMUNITY BUSINESS LICENCING AND REGULATION OF TRADES, OCCUPATIONS AND BUSINESSES

WHEREAS Council may, pursuant to Section 8(6) of the Community Charter, regulate in relation to business;

AND WHEREAS pursuant to Section 14 of the Community Charter, two or more municipalities may, by bylaw adopted by the Council of each participating municipality, establish an Inter-Community scheme in relation to one or more matters;

AND WHEREAS pursuant to Section 15(1) of the Community Charter, Council may provide terms and conditions that may be imposed for obtaining, continuing to hold or renewing a licence, permit or approval and specify the nature of the terms and conditions and who may impose them;

AND WHEREAS Council has given notice of its intention to adopt this bylaw by publishing such notice in two consecutive issues of a newspaper, the last publication appearing not less than three (3) and not more than ten (10) days before the hearing and has provided an opportunity for persons who consider they are affected by this bylaw to make representations to Council at a hearing pursuant to Section 59 of the Community Charter,

NOW THEREFORE the Council of the District of ##### in open meeting assembled, hereby ENACTS AS FOLLOWS:

1. Title

This Bylaw may be cited as the District of ##### "INTER-COMMUNITY BUSINESS LICENCE BYLAW 2015 NO. ####.

2. Definitions

In this bylaw, unless the context otherwise requires,

"Business" has the meaning as defined by the "Community Charter

Schedule - Definitions and Rules of Interpretation".

"Excluded Business" means a Business excluded from application for an

Inter-Community Business Licence and includes those Businesses referred to in Schedule 'A' attached hereto

and forming part of this Bylaw.

"Inter-Community Business" means a Business that performs a service or activity

within more than one Participating Municipality by

moving from client to client rather than having clients come to them.

This includes but is not limited to trades, plumbers, electricians, cleaning services, pest control or other similar Businesses. This does not include fruit stands, flea markets, trade shows or other similar Businesses.

"Inter-Community Business Licence"

means a Business Licence which authorizes Inter-Community Business to be carried on within the boundaries of any or all of the Participating Municipalities in accordance with this Bylaw and will be in addition to a Municipal Business Licence.

"Municipal Business Licence"

means a licence or permit, other than an Inter-Community Business Licence, issued by a Participating Municipality that authorizes a Business to be carried on within the jurisdictional boundaries of that Participating Municipality.

"Participating Municipality"

means the following local governments that have adopted the Inter-Community Business Licence Bylaw:

District of Tofino

District of Ucluelet

City of Campbell River

City of Courtenay

City of Duncan

City of Nanaimo

City of Parksville

City of Port Alberni

District of North Cowichan

District of Lantzville

Town of Comox

Town of Lake Cowichan

Town of Ladysmith

Town of Qualicum Beach

Village of Cumberland

"Person" has the meaning ascribed to it by the Interpretation Act.

"Premise" means a fixed or permanent location where the

applicant ordinarily carries on Business.

"Principal Municipality" means the Participating Municipality where a Business

is physically located, or has a Premise, or, where the licensee does not maintain a Premise in any of the Participating Municipalities, the municipality that issues

the Inter-Community Business Licence.

3. Regulations

- a) Subject to Section (c) and (e), a person who has obtained an Inter-Community Business Licence may carry on business within a Participating Municipality for the term authorized by the Inter-Community Business Licence without obtaining a Municipal Business Licence in the other Participating Municipalities.
- b) A Participating Municipality may issue an Inter-Community Business Licence to an applicant for an Inter-Community Business Licence provided the Business type is an Inter-Community Business and is not an Excluded Business, the applicant has a valid Municipal Business Licence issued by that Participating Municipality, and the applicant meets the requirements of this Bylaw.
- A person holding an Inter-Community Business Licence must comply with all other regulations and bylaws of the Participating Municipality in which they are carrying on Business.
- d) A Business that operates under an Inter-Community Business Licence in more than one Participating Municipality shall only apply for an Inter-Community Business Licence from the Participating Municipality in which they maintain a Premise.
- e) Notwithstanding the issuance of an Inter-Community Business Licence, every person who carries on, maintains, owns or operates, within a Participating Municipality, any profession, business, trade, occupation, calling, undertaking or thing in or from more than one branch, office, place, premise or store shall obtain a separate Municipal Business Licence for each branch, office, place, premise or store. And further, notwithstanding Sections (b), (c), and (d), the Participating Municipalities agree that where an applicant for an Inter-Community Business Licence:
 - i. does not maintain Premises in any of the Participating Municipalities, then the applicant may apply at any one of them; or
 - ii. maintains a Premise in more than one of the Participating Municipalities, the applicant must apply at one of the Participating Municipalities where they maintain a Premise.

4. Fees

- a) The fee for an Inter-Community Business Licence is \$150 and shall be paid in full at the time of application and will be retained by the Participating Municipality that issues the licence.
- b) The fee for an Inter-Community Business Licence is separate and additional to any Municipal Business Licence fee that may be required.

5. Application

- a) Every Inter-Community Business Licence shall be issued on a standard form provided for that purpose, as agreed upon from time to time by the Participating Municipalities and including, as a minimum, the following information:
 - Disclosing the nature and character of the profession, business, trade, occupation, calling, undertaking or thing to be carried on, maintained, owned or operated by the applicant;
 - ii. Declaring the mailing address and contact information for such profession, business, trade, occupation, calling, undertaking or thing;
 - iii. Declaring the number of persons engaged or occupied in such profession, business, trade, occupation, calling, undertaking or thing;
 - iv. Disclosing the number of distinctive lines of goods sold or offered for sale;
 - v. Including any other information concerning the profession, business, trade, occupation, calling, undertaking or thing which the Participating Municipality may require.
- b) Each Participating Municipality shall provide to all other Participating Municipalities standardized information regarding the Inter-Community Business Licences issued, by way of at least weekly updates on a shared database available to all Participating Municipalities.
- 6. Suspension or Cancellation of an Inter-Community Business Licence
 - a) A Council or Designated Officer or Employee of a participating municipality may exercise the authority of the Principal Municipality in accordance with Sections 15 and 60 of the Community Charter to suspend or cancel an Inter-Community Business Licence. The suspension or cancellation shall be in effect throughout all of the Participating Municipalities and it shall be unlawful for the holder to carry on the Business authorized by the Inter-Community Business Licence in any Participating Municipalities for the period of the suspension or cancellation.
 - b) Before suspending or canceling an Inter-Community Business Licence under Section 6(a), the Participating Municipality must give the licence holder notice of the proposed action and must inform the licence holder of their right to be heard.
 - i. If the licence holder wishes to exercise this right, the Participating Municipality shall communicate in writing to the licence holder and Principal Municipality that issued the Inter-Community Business Licence, together with such documentary evidence of the reasons for suspension or cancellation as may be available and the request to be heard. Such Principal Municipality shall then, as soon thereafter as reasonably possible, provide the Licence Holder an opportunity to address their respective Council who will then consider whether to suspend or cancel the Inter-Community Business Licence.

- ii. If the licence holder does not exercise their right to be heard, the Participating Municipality may suspend or cancel the Inter-Community Business Licence in accordance with Section 6(a).
- c) Any conduct by a licence holder resulting in a hearing made under Section 6(b)(i) shall be considered by the Council of the Principal Municipality as though it happened within the jurisdiction of the Principal Municipality.
- d) A decision by a Principal Municipality or Participating Municipality to cancel or suspend an Inter-Community Business Licence under Section 6 (b) shall be honoured by all Participating Municipalities.
- e) Nothing in this Bylaw impedes the authority of a Participating Municipality to suspend or cancel any Business Licence issued by that Municipality, or to enact regulations in respect of any class of Business Licence in accordance with Section 15 of the Community Charter and amendments thereto.

7. Miscellaneous

 a) A Participating Municipality may, by notice in writing to each of the other Participating Municipalities, withdraw from the Inter-Community Business Licence scheme established by this Bylaw.

Notice must:

- Set out the date on which the withdrawing Municipality will no longer recognize the validity within its boundaries of business licences issued pursuant to this Bylaw, which date must be at least six months from the date of the notice; and
- ii. Include a certified copy of the Bylaw authorizing the withdrawal.
- b) An Inter-Community Business Licence issued prior to the effective date of the withdrawal shall, until it expires, remain valid within the boundaries of the withdrawing Municipality.

8. Severability

a) If any section, paragraph or phrase in this Bylaw is for any reason held to be invalid by a decision of a Court of competent jurisdiction, that portion shall be severed and the remainder of this Bylaw shall continue in full force and effect.

9. Effective Date:

This Bylaw shall come into full force and effect on the first day January 2014.

RECOMMENDATION(S):

1. **THAT** Council award the Municipal SCADA systems Head-End Systems Upgrades proposal to PBX Engineering for the amount of \$57,010.00;

<u>or</u>

2. **THAT** Council request the scope of the work be reduced to exclude the addition of the wastewater system;

or

3. **THAT** no award be made at this time.

PURPOSE:

The purpose of this report is to obtain Council approval to award the above-mentioned proposal. Work carried out under this proposal includes ClearSCADA Primary Server Upgrade (hardware and software), Additional Wastewater System, Call-out system, System reporting, User manuals, Operator "cheat sheet", training and three other remote sites in two locations online.

BACKGROUND:

Supervisory Control and Data Acquisition Systems (SCADA) are systems used to monitor and control remote facilities such as water pump stations and sewer pumping stations from a central location. The control is performed by Remote Terminal Units (RTU) (SCADA PAC) or Programmable Logic Controllers (PLC's) located at the remote sites. Parameters set in in these units are transmitted to the master Central Terminal Unit (CTU) located at the Public Works Yard via an Ethernet based radio network with a TELUS dial-up line/cellular modem system.

The District currently runs SCADA in four locations: Lost Shoe Wellfield, Highway Reservoir, Bay St. Water Treatment Facility, and Matterson Reservoir. The District has three sites with the Remote Terminal Units (RTU) (SCADA PAC) in them.

The existing master Central Terminal Unit (CTU) has a number of shortfalls that affect the usability of the system. The software and hardware is obsolete and is no longer supported by the manufacturers.

Staff requested proposals and received a submittal from PBX Engineering. Their proposal was reviewed by Staff, who concluded the proposal met the needs for SCADA work required for the District of Ucluelet for this year.

Work to be carried out in the proposal is as follows:

- SCADA software and hardware configuration
- Additional wastewater system, which will allow for the integration of the wastewater system into the SCADA software
- Call-out system: the development and configuration of the call-out system will be configured to send out email alerts in response to alarm and event conditions within the system.
- System Reporting: the system will be programmed to allow for the generation of reports required to be submitted to the Ministry of Environment for annual reporting.
- User manuals to be developed: these will include descriptions of the system operation and will include screenshots for each station. These manuals will be used for operator training and troubleshooting.
- Operator Training: staff will go through a day of training with the company.

Options

- 1. Award the proposed work to PBX Engineering for the amount of \$57,010.00
- 2. Reduce the scope of the work to exclude the addition of the wastewater system
- 3. Do not do any work this year

Option #1 is preferred by Staff.

SUMMARY AND CONCLUSION:

Staff are satisfied with the proposal submitted by PBX Engineering and that the firm is qualified to do the work. The proposal submitted by PBX Engineering does not exceed the allocated SCADA budget for 2015.

PURPOSE:

In order to exempt certain properties from municipal property taxes, the above noted bylaw must be adopted on or before October 31st in the year prior to the next taxation year. This will exempt these certain properties from land and/or improvement taxes for the taxation year of 2016.

DISTRICT OF UCLUELET BYLAW NO. 1185, 2015

"A Bylaw to Exempt Certain Lands and/or Improvements from Municipal Property Taxation for the 2016 taxation year"

WHEREAS, the Community Charter provides general exemptions from taxation;

AND WHEREAS, the *Community Charter* provides qualifications and exceptions to the general exemptions provided;

AND WHEREAS, the *Community Charter* empowers Council of the District of Ucluelet to, by bylaw adopted by 2/3 of its members; exempt certain lands or improvements or both from taxation;

AND WHEREAS, pursuant to the *School Act* as amended, property that is exempted from taxation under the *Community Charter* is also exempted from taxation under the *School Act*;

AND WHEREAS, it is deemed advisable to enact a new bylaw granting exemption to public worship properties, museum properties, and the interest in municipal buildings of a non-profit organization that uses or occupies as a tenant of the municipality;

NOW THEREFORE the Council of the District of Ucluelet enacts as follows:

Title

1) This bylaw may be cited as "Ucluelet Municipal Property Tax Exemption Bylaw No. 1185, 2015."

Exemption for Public Worship Properties

- 2) The land hereinafter described and the improvements thereon which are set apart and in use for public worship are hereby exempt from taxation under the *Community Charter* for the year 2015.
 - a) Lots 1 and 2, Section 21, Clayoquot Land District, Plan 9522 registered in the name of the Christ Community Church of Ucluelet;
 - b) Lot 1, District Lot 282, Clayoquot Land District, Plan 10396 and Lot 1, District Lot 282, Clayoquot Land District, Plan 9024 registered in the name of the Bishop of Victoria;
 - c) Lot 6, District Lot 282, Clayoquot Land District, Plan 30080 registered in the name of the Ucluelet Congregation of Jehovah's Witnesses.

Exemption for Museum Properties

3) The land hereinafter described and the improvements thereon which are set apart and in use for a museum are hereby exempt from taxation under the *Community Charter* for the year 2015.

a) Folio 196.410, Block A, District Lot 1507, Clayoquot Land District, Plan 61995, Survey Plan filed with Active Lease to Ucluelet & Area Historical Society, Lands Branch Lease #111228.

Exemption for Non-Profit Organizations Using Municipal Property

- 4) The interest in municipal buildings of a non-profit organization that uses or occupies as a licensee or tenant of the municipality are hereby exempt from taxation under the *Community Charter* for the year 2015.
 - a) Food Bank on the Edge 160 Sea Plane Base Road Roll No. 181.060 being that portion of Lot 3, Plan 20323, District Lot 284, Clayoquot Land District that is used and owned by the Food Bank on the Edge;
 - b) Westcoast Community Resources Centre 500 Matterson Drive Roll No. 114.960 being that portion of Lot A, Plan VIP56963, District Lot 281, Clayoquot Land District that is used by the Westcoast Community Resources Centre;
 - c) Nuu-Chah-Nulth 500 Matterson Drive Roll No. 114.960 being that portion of Lot A, Plan VIP56963, District Lot 281, Clayoquot Land District that is used by the Nuu-Chah-Nulth First Nations;
 - d) Ministry of Child and Family Development 500 Matterson Drive Roll No. 114.960 being that portion of Lot A, Plan VIP56963, District Lot 281, Clayoquot Land District that is used by the Ministry of Child and Family Development;
 - e) Vancouver Island Regional Library 500 Matterson Drive Roll No. 114.960 being that portion of Lot A, Plan VIP56963, District Lot 281, Clayoquot Land District that is used by the Vancouver Island Regional Library;
 - f) Ucluelet Daycare Society 500 Matterson Drive Roll No. 114.960 being that portion of Lot A, Plan VIP56963, District Lot 281, Clayoquot Land District that is used by the Ucluelet Daycare Society.

Exemption for Recreational Properties

- 5) The land and improvements classified by the BC Assessment Authority as Class 8 (Recreation/Non-Profit) and excluding the land and improvements classified by the BC Assessment Authority as Class 6 are hereby exempt from taxation under the *Community Charter* for the year 2015.

Exemption for Aquarium

6) Ucluelet Aquarium Society – Folio 152.020 being a Portion of District Lot 1689, Clayoquot Land District for aquarium purposes, license 113490.

Exemption for Land Leased by the Municipality
