Council requested an update on options for grant funding for addition of new lines; CAO provided that Island Coastal Economic Trust remains a possibility as a funder once the project is laid out

3. PUBLIC INPUT AND PRESENTATIONS:

3.1 Presentation of Harbour Services Kevin Cortes, Harbour Contractor

The Harbour Authority received a presentation on the areas of responsibility overseen by the Harbour Contractor, including hours spent on tasks and makeup of the Harbour Contractor's staff team

- Council asked questions pertaining to:
 - Education on water conservation (some done last year)
 - Mr. Cortes' view on the installation of a gate at the Main Street dock (feel it would be received negatively by pedestrians)
 - If the dock in Port Albion was in Mr. Cortes' contract (it is not)
 - Number of summer staff employed (2 fulltime, 1 part-time)
 - How well business is going (fluctuates with US economy and fish availability)
 - Noticing trends in use (feel recreational use will continue to climb)
 - Mr. Cortes' thoughts on adequacy of parking (very busy in July and August, boats and trailers often overflow onto Lyche and Hemlock, would be helpful to find long-term parking options - currently attempt to redirect those with trailers to Seaplane Base)

- Any complaints on change in rates (mainly with change to 6 month reservations)
- Number of sportsfishers (last year had 47 at one time, around 40 companies use the docks)
- Council thanked Mr. Cortes for his presentation and remarked on the extensive positive feedback they receive on his work

RE: INCREASED NOISE POLLUTION BY COMMERCIAL FISHING BOATS AND THE INFRACTION OF OUR PRESERVED VIEW AS SHOWN IN THE O.C.P.

AS A LONG TIME RESIDENT (38 YEARS+) AT 145 WATER FRONT DRIVE I AM INCREASINGLY FRUSTRATED AT THE NOISE POLLUTION AT THE OUTER BOAT BASIN LOCATED DIRECTLY IN FRONT OFOUR HOME. IT HAS BEEN PARTICULARLY EXCESSIVE THAS SUMMER OF 2016. LOUD GENERATORS AND BLINDING FLOOD LIGHTS ARE RUNNING 24 HOURS PER DAY, MAKING IT VERY INTRUSIVE AND ALMOST IMPOSSIBLE TO SLEEP WE ARE AWARE OF THE UCLUELET BYLAW 915 WHICH PROHIBITS PERSISTENT NOISE AND SOUNDS WHICH DISTURB THE COMFORT AND CONVENIENCE OF PERSONS IN THE VICINITY, THAT BEING US AND THAT OF OUR NEIGHBOURS. WE UNDERSTAND THERE IS TO BE AN EXPANSION OF THE JAPANESE DOCK. WE, BEING ADJACENT TO THIS FACILITY HAVE NEVER BEEN NOTIFIED OF THIS EXPANSION. THE ADDITION OF MORE DOCKS MEANS MORE COMMERCIAL VESSELS, THEREFORE OBSTRUCTING OUR PRESERVED VIEW, AN INFRACTION SHOWN IN THE O.C.P SEP 1 4 2016

Noise pollution by commercial fishing boats

Dear Mayor and Council

This note is to advise you of a noise pollution issue to which we hope the Boat Basin and the Town can direct immediate remedial attention.

We have owned a unit in Water's Edge adjacent to the Japenese dock for almost ten years. In previous years the commercial fishing boats kept their noise pretty well under control. However, this summer it has gone out of control. From our perspective, the worst offender has been the fishing boat Lofoten (departed 09/10), which kept a very loud diesel generator running 24/7 for almost 3 weeks. This has interfered greatly with our sleep and enjoyment of our unit.

Other adjacent property owners have had similar experience.

Attached please find a copy of Ucluelet ByLaw 915 (attached). It seems clear from the highlighted text that this excessive noise violates the bylaw, particularly the paragraph on diesel engines.

If not corrected now, this matter promises to get much worse with the imminent expansion of the Japanese dock, and plans to moor more commercial vessels here. In addition to the noise intrusion, is the fact that further increased noise will adversely impact community property values.

It's time to nip this thing in the bud.

We have no problem with transient commercial fishing vessels using the harbor facility. We do have a problem with intrusive noise.

This appears to be a solvable problem.

Dear Mayor and Council,

My name is Robert Edy and I live at the Water's Edge. It may be just my age and memory leading me astray here, but I could have sworn someone told me that the Japanese Dock was going to have an electrical upgrade which would allow the trawlers to plug into shore power and not have to run their generators 24/7.

Obviously I have a personal reason to enquire about this as I, and my neighbours find the noise very annoying and when the wind is right, the fumes are awful. I have been told that the boats also, would rather use shore power than run their generators.

I did see Hydro putting in a new pole and what looked like a new service at the beginning of the dock. I thought that was the beginning of the improved service. (apparently not)

I don't know the costs of doing this, but I kind of think it would be like hooking two fish with one hook. The fishers would be happy, the neighbours would be happy, the environment would be better, and the Harbour Authority could be making some good cash from the new service.

I would like to hear what you think about my thoughts. (I could be totally off base here, but I thought it would be worth this short letter)

Report to the Harbour Authority

June:

We had 30 gill net boats as well as 5 Salmon packers fishing in Barkley Sound and spent most of the final three weeks of June on our docks. Due to significant bycatch issues our shrimp fleet was shut down and most of the boats returned to their home ports. By the end of the month we had the majority of the summer charter fleets at the dock. (44 fishing charter boats for 28 companies, 3 whale watcher boats 2 companies)

July:

The combination of warm water off shore near the US border and high NW winds we had 55 commercial tuna boats on the dock, most for more than two weeks waiting out the weather. The salmon catch rate for the recreational fishers was quite low for this time of year.

August:

Winds continued to hamper the majority of the tuna fleet in the first half of the month keeping most still tied to the dock. On the 6th the Salmon trollers left to fish at Esperanza and were gone for the rest of the month. Recreational salmon fishing improved for most of August the average size in the mid-upper teens.

Operations:

The office hours were open 6:30 -20:00 7 days a week. I added my summer staff (James, Katlyn and Kassidy) for June-September.
