RE: Watermain Connection Willowbrae Road

Good Morning Bruce Greig:

I am writing the District of Ucluelet Council to request their support in our application for the Community Economic Recovery Infrastructure Program (CERIP). The provincial government recently announced this program, and we are seeking to access funds with the intent to improve our water infrastructure at Willowbrae Road. With this infrastructure in place we can also improve our fire protection systems at the coastal Wya Point lodging. We have been planning to improve this infrastructure for a number of years now and are seeking your support at this time.

With the installation of a water meter at this location the District of Ucluelet will be able to monitor our water usage and charge a user fee as needed. All piping and fire protection systems downstream of this utility connection will be maintained and operated by the Yuułu?ił?ath Government.

In the future we hope to continue open discussions with your Council and will be participating in the upcoming Land Use Demand planning your municipality has initiated through Island Coastal Economic Trust (ICET). I am requesting your letter of support for this CERIP application as willing neighbours to support a watermain connection at this roadway junction.
