- The Harbour Master Plan engagement period has been extended to December 15, 2020 and they have received 36 responses to date;
- Harbour revenues are within a couple hundred dollars of last year and revenues are expected to be similar in 2021.
- There has been some pushback regarding the fees for Thorton Creek Hatchery and the Ucluelet Royal Marine Search and Rescue but Staff plan to present amendments to the Habour Regulation Bylaw to legislate these fees.

Staff noted that the Ucluelet Aquarium is still working towards completing the educational signage to accompany the fish scale by spring of 2021.

#### **PURPOSE:**

To provide the Harbour Authority with an update regarding the Ucluelet Harbour Master Plan.

#### **BACKGROUND:**

The purpose of the Ucluelet Harbour Master Plan (the "Plan") is to provide a vision for the harbour that meets the community's needs and provides pathways for implementation. The Plan supports the vision, goals and objectives of the Draft 2018 Official Community Plan, 2017 Economic Development Plan and 2019-2022 Strategic Plan.

The process for developing the plan is as follows:

- 1. Project initiation and background review;
- 2. Site inventory and analysis;
- 3. Key partner & stakeholder engagement;
- 4. Draft Harbour Master Plan report;
- 5. Focused virtual group meetings; and
- 6. Finalize and submit Harbour Master Plan report.

The Plan will be an inclusive and user-friendly document to guide future decision making and support upcoming funding opportunities. It will also strive to meet the dual requirements of DFO and District of Ucluelet and comply with all applicable legislation, while balancing the unique needs of key partners and stakeholders, including but not limited to commercial and sport fisheries, First Nations, and tourism and recreational users.



#### **UPDATE ON ENGAGEMENT PROCESS:**

- Community partner and stakeholder survey and interactive map was available on the District's project webpage from **November 1 to December 13, 2020**. The questions focused on gaining a better understanding of how and when Ucluelet's Harbours are used.
- A total of **43 responses** were received, including both online and paper copies.
  - Engagement summary key themes, etc. will be presented at the upcoming Harbour Authority meeting.
- Virtual workshops upcoming **March 1-3, 2021** (incl. local District support):
  - Commercial fishing operators (Harbour Master)
  - Tourism operators (Tourism Ucluelet)
  - Businesses and landowners (Ucluelet Chamber of Commerce)

#### **SCHEDULE**

- Complete engagement process and finalize report: February to April 2021
- Present to Harbour Authority for Adoption: May 4, 2021

#### **FINANCIAL IMPACTS:**

Contract value increased in January 2021 due to COVID and additional engagement requirements and has been presented through the District budget process.

#### PURPOSE:

To present the 2021 Small Craft Harbour projects to the Harbour Authority for information, discussion and support.

#### **BACKGROUND:**

In 2020 several Small Craft Harbour projects were completed. A defibrillator for the Small Craft Harbour was purchased, new pilings at Whiskey Dock were installed and a weigh station with signage was also installed so locals and visitors can show-off the days catch.

Some projects were temporarily put-on hold for several reasons, primarily related to COVID-19. The intent is to carry-over the projects of cleaning station education signage, EV charger install, boat launch design (through the Harbour Master Plan), and revisit the Harbour Master boat procurement.

The following is a list of proposed projects as recommended by the Harbour Master in conjunction with the Manager of Recreation & Tourism. These projects plan for the future, address infrastructure issues, improve tourism assets, and beautify the space.

#### **2021 Proposed Projects**

- Harbour Master Plan \$12,000 (additional funds required to complete this project)
   (COVID, Online platforms, extension)
- New pilings at Whiskey Dock \$30,000
- SCH Beautification ongoing- \$10,000

- Washrooms painting and upgrades \$12,000
- Asphalt pathways \$15,000
- Water's Edge walkway \$65,000 redesign

#### **Carry-Forward**

- Cleaning Station Education Signage \$10,000

- Boat launch design \$10,000
- Harbour Master Boat procurement \$20,000

#### Proposed/Carry-Forward Total: \$184,000

#### **FINANCIAL IMPACTS:**

Although, there are no direct tax implications for the 2021 Small Craft Harbour proposed projects to the community, \$184,000 would be required from the Small Craft Harbour Reserve Fund.
